- 1. Review this plan every semester with your Faculty Advisor. Bring questions to the Director of Graduate Studies. Any exceptions to the required coursework must be approved by the Director of Graduate Studies and the Field Chair for that field.
- 2. If you select American as one of your fields, then you must take at least one course from each of the following subsets:
 - a. Behavior (Electoral Behavior, Public Opinion, Psychological Approaches...)
 - b. Institutions (Legislative Process, Presidency, Parties)
- 3. If you select Comparative as one of your fields, then you should take Comparative Political Analysis before comprehensive exams
- 4. If you select Public Policy as one of your fields, then you should take Public Policy Analysis before comprehensive exams
- 5. Summer "math camp" normally is taken during the summer after your first year. It does not apply to a Major, Minor, Elective, or Tools requirement. It counts for 0 credits and therefore does not count towards the 45 hours.
- 6. Enroll in at least one course every Fall and Spring semester until the degree is awarded.
- 7. You must finish the entire program, including dissertation, within 10 years. You must complete your dissertation within 5 years after passing comprehensive exams.
