Scholarship applicant exhibits leadership qualities as determined by the Psychology Department Graduate Education Committee.

The Psychology Department Graduate Education Committee will solicit eligible candidates from the interdisciplinary neuroscience program to apply.

Scholarship applicant should demonstrate an interest in research in neuroscience directed towards brain function.

Scholarship applicant must be a certified full-time graduate degree-seeking student in good standing at the University of Houston.

Priority given to applicants actively studying sensory and cognitive neuroscience, and especially those using non-invasive methods with potential clinical applications.

Scholarship recipient must maintain a GPA in accordance with the standards set by the Psychology Department Graduate Education Committee.

Scholarship recipient may accept other scholarships and grants in conjunction with the **Anh Lac Tran Scholarship**.

Funds can be used to cover expenses for tuition, books, fees, and/or supplies for the coming academic semester. Any expenses of a recipient in excess of the amount deposited must be borne by the student.
