At my request, University will install equipment and provide me with cable television service. In consideration therefore, subject to applicable laws and regulations, I AGREE AS FOLLOWS:

- OWNERSHIP OF EQUIPMENT.** The cable television service jack (the "Equipment") installed in my room is the exclusive property of University.
- ACCESS TO EQUIPMENT.** University may have access to Equipment in my room at all times. University is not responsible for the operation, maintenance, service or repair of any television set, VCR, or radio in my room.
- DAMAGE TO EQUIPMENT.** I will take reasonable care to prevent damage to Equipment and I agree to pay University for the repair or replacement for such unit regardless of the cause of damage.
- TAMPERING WITH EQUIPMENT.** I will not, nor will I permit others, to move, alter or tamper with Equipment, or use it contrary to this Agreement. I understand that the service is only allowed for the connection of Equipment to one set of receiver, within the room stated in this agreement. Further, I will not connect or attach, directly or indirectly, any additional television set, VCR or other device to Equipment without the express permission of University.
- DISCONNECTION.** Once cable is provided for the student, the cable service will not be disconnected as long as the subscriber remains a resident in University. Cable services may be relocated to another room if subscriber goes through a room transfer with in University.
- CHANGE IN SERVICES AND RATES.** I understand that the rates are subject to change.
- SERVICE INTERRUPTIONS.** University will not be held responsible for any service interruptions.
- PAYMENT.** There are no application fees or installation charges. The cable service is provided at the rate of a one-time payment of \$ 40 per semester or \$ 1 per day with a minimum of 5 days (conferees only).
- ASSIGNMENT.** I may not assign or transfer this agreement.
- MISCELLANEOUS.** No representation, statement or warranty other than as specifically set forth herein shall be binding upon me or University. I further understand and agree that University may, in its sole discretion, refuse future cable service to me should I willfully and knowingly violate any term of this Agreement. In the event of a conflict between a provision of this Agreement and any law or regulation, the conflicting provision shall be modified or deleted as necessary to make it consistent with such law or regulation. All other provisions of this agreement shall remain in full force and effect.
- PROSECUTION.** I understand that if I knowingly or unknowingly break any of the codes in this agreement, I will be prosecuted to the maximum penalty allowed by the law.

State law requires that you be informed of the following: (1) with few exceptions, you are entitled on request to be informed about the information University collects about you by use of this form; (2) under sections 552.021 and 552.023 of the Government Code, you are entitled to receive and review the information; and (3) under section 559.004 of the Government Code, you are entitled to have University correct information about you that is incorrect.
