- Satisfactory Academic Progress (SAP)
- Enroll in at least **9 credit hours** per semester of award
- Cumulative **GPA of 2.50**
- Complete/Pass **24 credit hours** in an academic year
- Pass **75% of all classes attempted** in an academic year

A student is no longer eligible for the TEXAS Grant when one of the following is met:

- **150 credit hours** paid by the grant or **90 credit hours** paid by the grant for those who received the initial award via an associate's degree
- **5 years (10 semesters)** from initial award or **3 years (6 semesters)** from initial award for those who received the initial award via an associate's degree
- **Bachelor's degree** is obtained
