Campus Incidents

07-1612 – Forgery – 12/20/07 10:32 a.m. – UH Police Station – Gremillion – A student employee falsified a governmental document used to record work hours. The falsified document was presented for payment. Occurred between 10:32 a.m. 9/5/07 and 10:32 a.m. 12/12/07.

07-1614 – Failure to Stop and Render Aid – 12/21/07 10:35 a.m. – Cullen Oaks Apartments – Raulerson – A student reported that her vehicle was struck and damaged by another while on a public roadway.
