Campus Incidents

08-0152 – Theft – 2/8/08 9:02 a.m. – Graduate School of Social Work – Cotton – A student reported that someone rifled through her unattended wallet and stole cash. There are no witnesses, however, the complainant believes she knows of one person who was alone in the room with her property, but does not want to accuse anyone.
