Campus Incidents

08-0395 – Theft – 4/4/08 3:30 p.m. – Roy Cullen Bldg. – Cotton – A visitor attending language classes at Roy Cullen building left his backpack unattended outside the building and when he returned to get his backpack he discovered that it was missing. There are no suspects or witnesses. This incident occurred between 2:57 p.m. and 3 p.m. 4/4/08.
