Simon Bott thanked Charles Peters and the subcommittee for their hard work in reviewing these items expeditiously. Martha Dunkelberger on behalf of the Communication Sciences and Disorders department thanked the UC for their help in this task.

B Ad Hoc Subcommittee on Academic Honesty Policy Subcommittee – Larry Williams, Chair

Larry Williams gave a brief summary of the Ad Hoc subcommittee report and then Q & A discussion followed.

UC members began with concerns/comments regarding the term “visible possession” in section 3.02m. The Committee discussed the differences of actual possession v.s. visible possession of

electronic devices during class. The Academic Honesty Committee that revised the policy mentioned that this clause was made as general as possible and that it would leave it up to the faculty to be restrictive as they choose (i.e., ask students to leave cell phone turned off/face down on desks, place electronic device in backpack against a wall during class, etc.).

Dr. Williams asked that Jeanette Morales take notes of additional comments that would be added to the subcommittee report so that the UC will have all input in one place.

David Phillips suggested that further clarification on plagiarism is needed for students. Possibly adding a paragraph specifying what plagiarism includes would be helpful.

Charles Peters expressed his concern regarding section 5.01 (Reset clause: to give students reasonable time to review evidence, etc.). He felt that this clause implied adding another unnecessary level of appeal. Members of the Ad Hoc Committee clarified for him that this is not the intent. Dave Shattuck mentioned that resets are generally given at the discretion of the department. A few UC members thought the term “department chair” is not appropriate and may contribute to the confusion of who is in charge of resets of departmental hearings: possibly a “presiding officer of the hearing” or “department hearing designee” would be a better term. Tamara Fish recommended that instructors be added to this reset clause. Instructors as well as students should also have the opportunity to make reset requests. Heidi Kennedy on behalf of the Ad Hoc Committee that revised the Academic Honesty Policy accepted this friendly amendment.

Simon Bott asked Heidi Kennedy and the Ad Hoc Committee that revised the Academic Honesty Policy to consider and make the appropriate edits as suggested by the UC in writing. A final copy of the revised academic honesty policy should be sent to the UC for email vote (in lieu of holding a formal UC meeting on July 11). Heidi Kennedy thanked the Committee on their hard work on reviewing this policy and for helping to expedite the request to have it placed in the fall 2012 – summer 2013 Undergraduate Catalog.

Simon Bott thanked Larry Williams and the subcommittee on a good job reviewing this important policy.

V UC 11790 12S: Amendment to the Academic Fresh Start Policy

Djuana Young, Executive Director of Admissions informed the UC that the amendments to the Academic Fresh Start policy were mainly to align UH’s Academic Fresh Start policy with the state’s Academic Fresh Start. Also, the Office of Admissions would like to include the proposed Academic Fresh Start Policy into the ApplyTexas application system. The first change was made to reflect UH’s current admission policies and procedures (i.e., readmitting students from suspension). Secondly, clarification was made as to who can pursue this option.

The Committee approved the above mentioned item.

Simon Bott asked David Shattuck to explain why the College of Engineering is deleting this program. The UC would like to keep the reasoning in mind for future reference when other departments decide to create “pre-programs” for their prospective majors.

Basically, the College of Engineering didn't want to use the pre engineering program as a measurement of retention/graduation and it wasn't financially viable to sustain.

He mentioned that he's unsure when the timeband resolution will be finalized. However, the next step is to send proposed options/ideas to faculty for input.

Barry Wood had mentioned his concern with off campus time bands. The Committee suggested that he contact the department of Distance Education.
