GPSC chair Doug Eikenburg explained to the UCC the need for changes to the existing graduate course withdrawal policy and procedures. Essentially, graduate students are not fully aware of the ramifications of dropping courses. Dropping courses can affect graduate students' full-time enrollment, GATF, and immigration status if graduate student is an international student. Also, he had mentioned that other colleges/departments need to know the ramifications of graduate students dropping courses and how it affects their graduate students' employment in other departments.

### VI Old Business

UCC Chair Mark Clarke informed the UCC members that a MAPP which will officially establish the UCC at the University of Houston is in process as well as a MAPP on Course Syllabi. Both MAPPs will be coming to the UCC soon. The UCC MAPP should lay out the UCC workflow process and insert the UCC early in the workflow process (especially when creating MAPPS). Randall Lee and the Faculty Governance Committee will create a UCC workflow process plan and will present to the UCC at the next meeting. The UCC was encouraged to send comments to Randall Lee regarding this task.

Mark Clarke also reiterated that the mission of the University Coordinating Commission is to acknowledge proposed policies and ensure that they are distributed to appropriate campus groups. The UCC's goal is not to change policy. Elaine Charlson had mentioned that the UCC has done a good job at upholding the UCC's mission. Mark Clarke expressed President Renu Khator's concerns to the UCC members that the UCC processing timeline will not increase and hold up proposed policies that otherwise need to be implemented in a timely manner. Secondly, the UCC needs to ensure a "fast track" process is finalized so that proposed policies that need to be expedited, can be processed quicker rather than going through the standard thirty-day processing period. Currently, the UCC Chair holds the administrative power to utilize the fast track method to certify proposed policies. It was suggested that maybe 2-3 key UCC members can help fast track a proposed policy. Mark Clarke will review and seek advice.
