 - 2. Would like to get involved more with the dining program
- d. Vote
 - i. Anonymous in Favor
 - ii. Canyon is the New Vice-Chair
- 4. Residential At-Large Appointments
 - a. 4 applicants applied.
 - i. As a committee it was decided to select 3 out of the 4
 - 1. Nancy Sheoni here today and will become the general representative
 - 2. Ashley Hegger unable to attend will fulfill one of the residential representative positions
 - 3. Diana Marchione unable to attend but will fulfill one of the residential representative positions
- 5. UH Dining Services Updates & Information
 - a. Late Night Food Program
 - i. Extended through the end of the semester. Begins Monday 10/6 from 11pm 3am
 - ii. Located in the lot near Cougar Village 2 and the Student Service Bldg.
 - iii. Coreanos, Golden Grill and Happy Endings will rotate shifts
 - iv. Monday Thursday only one truck a night
 - v. Cougar Cash available to be used
 - vi. 500 transitions made during the pilot period. Pilot period covered 6 nights. About 90 transactions a night.
 - vii. Police presence has been confirmed with UHPD
 - viii. Advertised through RA, email blast, news release, and word of mouth from students.
 - b. Halal Luncheon Muslim Student Association
 - i. Launched a halal station to be shared with the Gluten-Friendly station .
 - ii. Served 500 plates when the usual is 200.
 - iii. Very good feedback received
 - iv. That station will have vegetarian, fish, and halal chicken items
 - c. What's Cooking Coogs? Program
 - i. First event was September 23rd and 31 students attended

- ii. Chef Carlos led the session
- iii. Video of the event not yet complete but when it comes out it will be sent to the committee
- d. Wellness Wednesday Workshops
 - i. Collaboration with Campus Recreation & Wellness Center
 - 1. Sarah Feye (UHDS Dietitian) has been working with the Recreation Center to do campus wellness workshops
 - 2. First one was Oct 1st about vegetarian day.
 - a. About the flexitarian diet.
 - ii. The next one is Oct 29th "Rethink your drink" and Dec 3rd "Healthy Holidays"
- e. Meatless Mondays
 - i. Apart of the Flexitarian diet life choice.
 - ii. Soy Milk Additions/Promotions
 - 1. Silk Soy Milk Give away on Sept. 29, which was a "Meatless Monday"
 - 2. To announce the addition of soy milk being in Cougar Woods
 - 3. Single Servings available to buy in the Cougar Village 1 C-Store
 - a. Only store available right now—due to test run
 - b. Doesn't need to be refrigerated
- f. UH Food Day
 - i. Guest Chef coming to campus Oct 22nd at Cougar Woods
 - ii. Chef Mikel Lawrence
 - 1. Supports the vegetarian movement here on campus and around the world
 - 2. Known as the skydiving chef
 - 3. Pairing it with world food day which is actually that Friday however this was pushed up for maximum exposure.
- g. Annual Dining Style Surveys
 - i. Oct 13 -Nov 3
 - ii. Goal to beat last year's responses- target at 1800.
 - iii. Last year was 1750 responses
 - iv. Dining student staff will go to the dining halls and give out surveys.
 - v. Results will be represented in the spring.
 - vi. Cougar Wood dining hours changed based off last year's survey.
 - 1. Hall Closes at 10 p.m. now instead of 8 p.m.
- 6. Member Items
 - a. No soups on Sunday in Fresh Food?
 - i. Administrative response: soups should be there daily. Will look into who was in charge that day.

- b. Food wasn't served passed 3 p.m. but full platter of food still out. Students upset when server refused to fill their plates
 - i. Administrative response: We will communicate more effectively to the servers that they aren't supposed to stop serving exactly at 3 but actually just start slowing down their serving. However they can still serve passed three if there are students waiting to be served.
- c. Can the leftover food be given to the homeless shelters in the area?
 - i. Administrative response: we do have a program already together; however, it is important to understand that the food already cooked and left out needs to be properly stored before it can donated
 - Food Donation Connection- they are in the area, looking for organizations in the area that would like to partner with us. For example we partner with Covenant House-adoption agency
 - iii. As a group we focus on how we can get more efficient on saving food and not over cooking.
- d. Summer menu planning. There is not a variety.
 - i. Administrative response: In the summer there are many conferences for young kids. Hot dogs & hamburgers are all that is requested by them.
- e. What is the final expected number of food trucks
 - i. There will mostly be 5 food trucks on campus at one time through the week.
 - ii. The program needs to be self-sustainable.
 - iii. It will hit a hitch in the middle of October when one of the pads goes away.
 - 1. Pad 2 will go off the grid because of the new building construction
 - iv. Can there be a UH App dedicated to food trucks on campus?
 - 1. At the moment there is a calendar online provided by Dining Services
 - 2. The food trucks themselves do their own twitter announcements that tell where they are.
 - v. Can the campus dish app have another page for Food Trucks?
 - 1. We will look into options.
 - vi. Will the hot chocolate machines be returned to the cafeteria?
 - Administrative response: Because they are always breaking, we find it a better customer service option to just not have them in the halls. We will look at either finding a better machine or a way to manage single servings.
- f. Meal Plan Sub-Committee still needs volunteers
 - i. Plans to change the meal plan structure
 - ii. Fall is busier than the Spring
 - iii. No set meeting time at this time, will be determined by the committee meetings
- g. Chick-fil-a closes too early can it be extended another 2 hours
 - i. The spring hours are currently being worked on for all locations.

- ii. Can they also add a screen for speeding up the order time
 - 1. UHDS is working on ways for CFA to become more efficient.
 - 2. A screen might not exactly be in their brand standards.
