#### **New Business:**

- 1. Call to Order: 9:17 a.m. by Chair McPherson.
- 2. Roll Call and acknowledgment of presence of Board members McPherson, Schwartz, Chowdry, and Paquin (non-voting ex-officio).
- UH Charter School students recently learned the role of a Board and how it affects the UH Charter School. Three UH Charter School students demonstrated their appreciation for the UH Charter School Board with a performance, certificates, a "hand" bouquet and breakfast.
- 4. Chair McPherson noted that no individuals signed up to speak and accordingly no Open Forum was necessary.
- Chair McPherson presented the Board Minutes from the October 25, 2016 Board Meeting for review and approval. No corrections to the Board Minutes. <u>Motion</u>: Representative Jonathan Schwartz moved to approve the October 25, 2016 Board Minutes, seconded by Representative Rozina Chowdry. The Motion passed unanimously.

- 6. UH Charter School Board Member Training: UH Charter School FY2016 Annual Financial Report (with Independent Auditors' Report Thereon) presented by Robert Belt and Stephanie Harris of Belt Harris Pechacek (Auditors). <u>Motion</u>: Representative Rozina Chowdry moved to approve the FY2016 Annual Financial Report, seconded by Representative Jonathan Schwartz. The Motion passed unanimously.
- 7. Lauri Schneidau Ruiz and Patricia Paquin presented information relating to proposed legislation affecting Charter School Accountability Ratings. The accountability ratings required by the Texas Education Agency do not accurately reflect the financial viability of charter schools operated by public universities in Texas. The Office of General Counsel and the UH Charter School are currently working with other Texas university charter schools and the Texas Education Agency in an effort to propose legislation that would provide for an accurate reporting method.
- 8. The UH Charter School is part of a larger, regularly scheduled audit of the College of Education. The entire internal audit was previously presented by UH Internal Auditor Don Guyton to the Audit and Compliance Committee of the University of Houston System Board of Regents, who in turn approved the audit at their December meeting. Accordingly, Patricia Paquin reviewed the related portions of the Triennial Internal Audit with the UH Charter School Board for informational purposes only. No vote is required on the Triennial Internal Audit by the UH Charter School Board.
- 9. Patricia Paquin presented the UH Charter School Quarterly Budget. No vote is required on the Quarterly Budget.

- 10. Patricia Paquin presented the Principal's Report on the UH Charter School. There have been many activities at the UH Charter School, including a Family Day at 2 football games, a visit from the UH Biomedical Engineering group with experiments and laser light shows, Family Math Night, Book Character Day, Fall Festival, Parent Night Out, Field Trips to the Crocodile Encounter, Moody Gardens, and Austin, a Veteran's Day Assembly that included a presentation from an ROTC Captain on Army Rangers, Portfolio Presentations, Navigators' Christmas Caroling, World Bazaar, 1st Annual "A Christmas to Remember," Spelling Bee, UH Charter School 20th Birthday Celebration, and Read Across America. No vote is required on the Principal's Report.
- 11. Patricia Paquin presented 2015-16 Texas Academic Performance Report. The UH Charter School 2016 Accountability Rating overall is "Met Standard." No vote is required on the 2015-16 Texas Academic Performance Report.
- 12. Patricia Paquin presented a HB2804 State Public School Academic Accountability System update. No vote is required.
