This seminar will focus on the power and impact of the relationships that we have as we work with, supervise, and mentor assistants, graduate clinicians, clinical fellows, new employees and colleagues in Speech-Language Pathology. Special emphasis will be placed on establishing a solid foundation in the art of giving and receiving feedback – great times and challenging times. We'll also be mindful of generational differences in the academic and work setting, and highlight a range of evidence-based success strategies that can be incorporated across community settings.
