# **DEFINITIONS**

### **Undocumented**

Foreign-born individuals who do not posses a valid visa or immigration documentation.

### **Dreamers**


Individuals/students who were brought into the US at a young age. They have lived and attended school in America for a majority of their lives.


### **DACA** Recipient

Individuals/students who benefit from Obama's 2012 Deferred Action for Childhood Arrivals (DACA) program. They are not a priority for deportation and hold a temporary work permit. They do not hold legal status.

## **DREAM ACT**

### Development, Relief, and Education for Alien Minors Act


A bill in Congress that would have granted legal status to certain undocumented immigrants who were brought to the United Sates as children and attended school here.

Over 10 versions of the bill have been introduced in Congress since 2001.

Bill has not passed despite holding widespread support in American public.

# DREAM ACT 2023 (S. 365)



#### What is it?

Bipartisan bill introduced in Senate February 9, 2023.

Provide Dreamers with protection from deportation and an opportunity to obtain legal status if they meet certain criteria.

Brought t the US before age 18, lived continuously in the US prior to the bill's enactment, pass a government background check, demonstrate that they were admitted into a college or university, have earned a high school diploma, or are in the process of earning a high school diploma or equivalent.



### Who does it help?

12.3 million eligible Dreamers

Individuals who were granted DACA would automatically qualify for conditional residency status.



# DACA

### **Deferred Action for Childhood Arrivals**

June 15, 2012

Temporary relief from deportation. Temporary work permit.

Proscecutorial discretion. Not a legal status. No pathway to citizenship.

Must renew every 2 years. \$495 renewal fee.





# DACA

### **Specific requirments:**

- Were under the age of 31 as of June 15, 2012 (that is, you were born on or after June 16, 1981);
- Came to the United States before reaching your 16th birthday;
- Have continuously resided in the United States since June 15, 2007, up to the time of filing your request for DACA;
- Were physically present in the United States on June 15, 2012, and at the time of filing your request for DACA with USCIS;
- Had no lawful immigration status on June 15, 2012, and at the time of filing your request for DACA, meaning that:
- You never had a lawful immigration status on or before June 15, 2012, or
- Any lawful immigration status or parole that you obtained had expired as of June 15, 2012, and
- Any lawful status that you had after June 15, 2012, expired or otherwise terminated before you submitted your request for DACA;
- Are currently enrolled in school, have graduated or obtained a certificate of completion from high school, have obtained a General Education Development (GED) certificate, or are an honorably discharged veteran of the United States Coast Guard or armed forces of the United States; and
- Have not been convicted of a felony, significant misdemeanor (that is, a misdemeanor as described in 8 CFR 236.22(b)(6)), or 3 or more other misdemeanors, and do not otherwise pose a threat to national security or public safety.



# DACA IN THE COURTS

September 2017

June 2020

July 2021

October 2022

Trump administration rescinded DACA program.

The Supreme Court ruled against the Trump administration's attempt to cancel DACA.

Judge Hanen from the U.S. District Court for the Southern District of Texas ruled that DACA is unlawful. DACA renewals may proceed, but no first-time applicants will be processed.

Fifth Circuit Court
agreed that DACA
is unlawful but
renewals for
existing DACA
recipients will
remain open.



# 2022 UNDOCUMENTED HIGH SCHOOL GRADUATES

### **Changing Trends**

100,000 undocumented high school graduates each year in 2022, 2023, 2024 Only 1/4 of 2022's eligible for DACA

### What does this mean for your students?

- Most undocumented high school graduates now are ineligible for DACA.
- They are attending college without an SSN.
- They are in danger of deportation and can not be legally employed.




# UNDOCUMENTED STUDENTS IN HIGHER EDUCATION

There is no federal law against U.S. colleges and universities accepting undocumented students.

Higher education access is determined at the institutional and state levels, meaning each state has different laws and policies in place that determine if and how undocumented students are able to access in-state tuition, if they qualify for state financial aid, and whether they can be admitted to the state's public universities.

# **TEXAS DREAM ACT**

### **Texas House Bill 1403**

Provides in-state tuition for Texans without legal status.

Provides eligible undocumented students with access to state financial aid, including state grants and state higher education loans.



### **Undocumented Students**

Immigration Reform and Control Act 1986: Federal law requires employers to verify that employees are legally authorized to work in the United States.

Under IRCA it is illegal to knowingly employ unauthorized workers in the U.S.

### **DACA Recipients**

Uncertain futures. May lose their SSN.
