Your application was selected for review in a process called “verification”. In this process, UH must compare the information from your FAFSA, your 2006 financial documents, and this worksheet and make corrections, if necessary. The documents must be received at least two weeks prior to the end of the semester. *If the requested documents are not received, any aid that you have received may be cancelled.* If your financial aid award changes due to verification, you will be notified in writing within 30 days of verification being complete.

What you need to do:

1. **Collect** your (and your spouse’s or parents’) financial documents (signed 2006 Federal income tax forms, W-2, etc.).
2. **Complete** the appropriate sections and **sign** the form - you (and your parent if appropriate).
3. **Submit** the completed worksheet, tax forms, W-2s and any other requested documents to the financial aid office.
