

# 2018 TAX RETURN STUDENT STATEMENT OF NON-FILING

Your FAFSA was selected for a review process called "Verification." Information from your FAFSA will be compared with signed copies of your 2018 Federal tax forms, or a 2018 Wage and Income Transcript or other financial documents. Federal law requires that we collect this information and complete verification before awarding Federal aid. If there are differences between your FAFSA information and your financial documents, corrections may be needed.

**This form should ONLY be submitted if your FAFSA application was selected for the verification process**

**INSTRUCTIONS: All students must complete sections 1 & 3. Only Independent Students are required to provide a 2018 IRS Verification of Non-Filing Letter or complete section 2 if you are unable to obtain a copy.**

## 1. U.S. Wages and Income Information
