UHPD Dispatcher: How can I help you?

Witness: Yeah, I just witnessed some girl screaming for help.

UHPD Dispatcher: I'm sorry?

Witness: Being assault by a Black...

UHPD Dispatcher: OK.

Witness: Yeah I just witnessed some girl (inaudible).

UHPD Dispatcher: OK, what location?

Witness: I'm here next to the SEC building.

UHPD Dispatcher: Near entrance (inaudible)?

Witness: I don't know where (inaudible)... yeah, behind in this alley.

UHPD Dispatcher: OK, she was in a alley?

Witness: Yeah, she's in (inaudible) right now.

UHPD Dispatcher: OK listen, can you see her?

Witness: Yes, I see her. I see a black male, tattoos on his arm.

UHPD Dispatcher: A black male with tattoos, what about the female?

UHPD Dispatcher: (Background: Hey Jason, this is in progress. In progress.) OK, it's a black male with Tattoos, listen listen. The girl, what does she look like?

Witness: I don't know I just see her black dark hair.

UHPD Dispatcher: With tattoos (inaudible). Listen, does he have any weapons?

Witness: I do not know and I do not want to get any closer.

UHPD Dispatcher: OK, you see them in the alley behind the Science and Engineering (inaudible)?

Witness: Yes, 3487 Cullen Boulevard.

UHPD Dispatcher: OK, what is he doing to her?

Witness: He's grabbing her, covering her mouth (Inaudible).

UHPD Dispatcher: OK, Is she white, Black, Hispanic? What is she wearing?

Witness: I cannot... I just saw her scream for help.

UHPD Dispatcher: That's OK, how long ago was this?

Witness: It's happening right now, I don't want to get closer. Right now.

UHPD Dispatcher: Right now, you're looking at her?

Witness: Yeah.

UHPD Dispatcher: OK.

Witness: I backed away in case he was armed and he sees us.

UHPD Dispatcher: OK. What is he wearing?

Witness: Gray, tank top (inaudible), bald.

UHPD Dispatcher: A gray tank, you said? He's bald?

Witness: Yeah, gray tank top, yeah. I don't see any hair.

UHPD Dispatcher: OK, you said he was covering her mouth?

Witness: Yeah, covering her mouth, she was screaming for help.

UHPD Dispatcher: OK, and what's around you? You said an alley.

Witness: 3487 Cullen Boulevard SEC 100 building. What else is around me? I'm in front of the Fertitta Center.

UHPD Dispatcher: OK, you're in front of the Fertitta Center. So, you're across the street looking at this?

Witness: Exactly, exactly, exactly. I still think it's (inaudible).

UHPD Dispatcher: That's OK we do have officers en route, OK. Can you tell me what else you see now? Do you still see them?

Witness: I don't want to get closer (inaudible)

UHPD Dispatcher: That's OK. Listen, listen. Just from where you are, you don't have to get closer. Can you still see them?

Witness: No, I can't see them. The generators I think are blocking my view.

UHPD Dispatcher: OK, like I said we do have officers en route. Can you just stay there and make sure the officers are going to the right location?

Witness: Yeah, I'm here.

UHPD Dispatcher: I'm going to stay on the line with you so you can keep me updated in case you do see them again. Ok.

Witness: No problem.

UHPD Dispatcher: OK, so which way did they go down the alley?

Witness: They like stopped in the alley I guess. It's an alley where there's dumpsters (inaudible).

UHPD Dispatcher: OK, but which way did he go through the alley, towards what?

Witness: Towards, I'd say Moore's Music School, yeah. I see the officers right now.

UHPD Dispatcher: You see the officers?

Witness: Yeah, they just arrived (inaudible).

UHPD Dispatcher: Did you want to see maybe, if you could get them to the right location?

Witness: Yeah, they're her right now. (Inaudible).

UHPD Dispatcher: Ok, you made contact with them?

Witness: Yeah yeah, they're here.

UHPD Dispatcher: Are you a student?

Witness: Yeah, I'm a student.

UHPD Dispatcher: OK, what's your PeopleSoft?

Witness: Yeah, it's still happening. He's got a knife, he's got a knife.
