Uniform Process

- UHS Purchasing Directors created uniform purchasing guidelines
- Same process and dollar thresholds
 - Spot Purchase: competition is not required, but use existing contracts and HUBs when possible
 - Informal Bids: contact at least 3 vendors directly, including 2 HUBs, for quotes by phone, fax, or email
 - Formal Bids: post bidding opportunity on Comptroller's Electronic State Business Daily (ESBD), which notifies vendors registered with the Comptroller, and require written responses by a stated deadline (2 to 3 weeks)
- Purchasing Directors have regular meetings to discuss process improvements and collaborate on HUB events

UH System Funds Only

- Purchasing Guidelines only apply to UHS funds
 - Not Agency Funds

Example: UH professor is chair of a national conference one year and uses an agency fund for depositing registration fees and paying conference expenses

- Not Foundation Funds
- Restricted Gift, Contract, or Grant Funds
 - Follows Purchasing Guidelines, but additional restrictions may be required by donor or sponsor



Best Value Considerations

Texas Education Code 51.9335

- Price
- Vendor's reputation
- Quality of goods or services
- Extent to which goods/services meet UHS needs
- Past performance with UHS
- Compliance with state rules related to HUBs and persons with disabilities
- Long-term cost to UHS

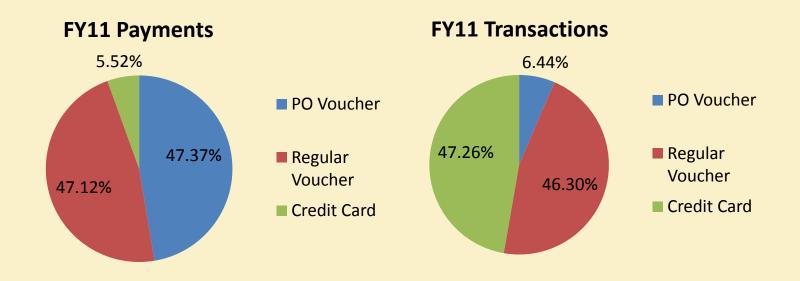
