  - a. Thank you for joining summer senate, this is an excellent turnout, so thank you very much.   - 4 2 Confirmed
    - a. Going to keep this short, Senior Resident Advisor & Resident Advisor in Housing, three key points. I advocate for my students and residents and being the voice of others. I believe this ties directly in to chairs of committees in advocating for any and all students. That advocacy followed through SRA council and getting achievements done.       - i. Question & Answer
        - 1. Leen What are your specific goals?
          - a. Advising is definitely one of them, funding is certainly not my first route. Advising across most colleges, would want passionate individuals from each college to work with me to bring students who care about advising
        - 2. Hunter What can SGA do differently?
          - a. Never received input on advising process and being a voice for students should really be heard before true conversation and decisions are made about what students need. I'd like to see a huge blast of communication to effectively get input from students through outreach so we can use the data to address what can be done.
        - 3. What do you see that could do different that passed previously?
          - a. They went funding route with NSM and it's not feasible for the next 5-10 years. So I'd like to evaluate resources and see if we can perfect the process.
        - 4. Paul What steps do you take, before taking over a team? What do you do to get settled in?

- a. If I don't know something I don't pretend to know it. I reach out to other resources that have the information, data, and experience to make better decisions for the team. I'd reach out to other senators and administrators for feedback.
- 5. Have you done any of those things?
  - a. Read over the bylaws and there is a lack of data there, however I know what material exists there. I think that this position requires more about the information that comes in with a team.
  - b. Reached out to Clint about his experience as well as Josh since he's changing a bit of what the roles are.
- 6. What about the committee members?
  - a. Regarding grade replacement yes
- 7. Chris How can you help me achieve my goals in academic affairs?
  - a. What are your girls?
- 8. 1) See admission process and tweak it a little bit 2) expand other aspects of the Undergraduate Committee
  - a. Depends on the process that's decided upon, if you were assigned the head of the task, it would depend on what you want to do. It would really be dependent on whoever is leading individual tasks. If I can't do what you'd like I'd reach out to those that can.
- 9. Fahad What are your thoughts on the amendments needed to grade replacement and whether you'll take an active role or work towards advising?
  - a. Depends on the committee and who wants to take roles. I don't want to take over projects without working with the individuals who have existing projects. I do want to focus on advising and I want to facilitate
- 10.Paul When answering Hunter's question you stated they failed due to financial route (NSM), you said it was due to the financial route.
  - a. Edwin talked to admin in NSM who discussed the information that I was provided.
- 11. Chris What is Academic Affairs supposed to be doing?
  - a. I don't believe there is anything specific as we haven't reached out to all the students yet. When we have more information from students we can better determine what course of action to take.
- ii. Con Pro Con

- Paul First like to start by highlighting that her answers, by stating she was going to find out and going to get more information. She doesn't know what she needs to know and we have others who do know who can produce results. I feel our senate has more experience.
- 2. Fahad First point I'd like to make, the fact that not knowing Academic Affairs job is, because she can't speak for the whole University. I highly doubt anyone here has evaluated what all students have needed. So I believe everyone is on a level playing field, so it shouldn't be counted against her.
- 3. Chris I believe Academic Affairs that are supposed to happen. That's why I asked her perspective. She didn't have a clue really, well her answers were vague and I don't like vague answers. I didn't feel like she knew what Academic Affairs was about.
  - a. Leen I feel like if you had a concern about her answer, you should've asked a follow up question.
- iii. Moderated Caucus 5 minutes
  - 1. Omar You mentioned an answer to be vague, you appear to have a distinct answer of what you wanted to hear. I heard a concern from students about allowing students to know about what is going on. I felt like you were subjective and I don't believe there is an end all be all.
  - 2. Hina The answer to what Academic Affairs is on the website, and she answered that through advising and grade replacement instead of addressing just specifics.
  - 3. Chris While making interesting points, I just wanted to hear her regurgitate what's on the site which makes me believe she didn't.
  - 4. Paul My line of questioning, there is a group that is concerned with individuals who don't want her as chair and I find it problematic that she hasn't reached out to those on the committee.
  - 5. Shane There are a certain number of senators trying to strong arm Josh in to who the chairs will be. I don't believe it's fair to say the group she will be working with is against her. Kayla reached out to those in the group.
  - 6. Hunter The idea to strong arm the speaker, AA members had a chat with Josh and wanted to instill same values, nobody is throwing a crying fit. We'll work with the person elected regardless, and we believe there is somebody more qualified.
  - 7. Leen Based off merit a person is proposing, a chair finds answers and pushes for needs of the students, not everyone knows everything and she stated she would do just that.

- III. Appointment of <u>Shawn Bhatia</u> to the position of <u>Assistant Director of External Affairs</u> 18 0 0 Confirmed
  - a. Legal assistant at a criminal law firm, worked in a congressional office, a media group, and the common denominator is governmental work and service. EA is all about working with external departments and entities. President of the Sikh Student Association & Vice-President of College Republicans.
    - i. Alejandro What are your goals?
      - 1. Wants to follow the guidelines in job description and organize UH Day at the Capital. Want to take on keeping Uber in Houston.
  - b. Delaney interviewed with 9 candidates, he had a lot of data and information on what External Affairs was all about. He has a lot of contacts and worked in lots of development in the community. He organized events in Washington D.C. and he's great at reaching out. He's very well spoken and qualified, it balances contacts on both sides of the aisle.
- IV. <u>University Bill 53001 Expansion of the Classmates Program</u> 18 0 0 Confirmed
  - a. Reading by Leen Basharat
    - i. This bill is really about expanding the program to positively impact student retention and success throughout CLASS. Current professors involved are advocating for this bill and the putting of individuals in to this program. CLASS students and committees all want this and CLASS senators will be signing this bill so it can go to the Dean for review.
  - b. Alejandro Just trying to extend the program to a full year?
    - i. The goal is to create a second set of courses so a total of 500 students can be in the program through two semesters, 250 each.
  - c. Hejal What would be the process for taking a classmates course vs. another history course?
    - i. Credit for the previous class doesn't allow you to take the program. However, you can take the second or first versions of a class, just not the one you use from an AP credit class counting towards your hours.
  - d. Chris If you enter Classmates how does enrollment operate?
    - i. It's exclusive, freshmen are sat down with advisors and it's an option for them. So they're enrolled at the beginning or not at all.
  - e. What you are saying is if you aren't in Classmates you can't take the course?
    - i. The professor still teaches the courses, you just can't take the Classmates time slot. So the professor is still teaching and can still be taken. However, one course is dedicated to the Classmates.
  - f. Hina How would hiring another advisor work?
    - i. Conversation with the director, they're trying to get more advisors for Classmates, and a half time advisor can't handle that. The director believes it's feasible after evaluating funding reports, just have to get student support.
