Clause 5: Executive, Speaker, Court, and Justice Department Reports

- I. Report of the President
  - Hey everyone, thank you for joining this meeting and I am hoping you are staying safe and healthy. It is unfortunate that yesterday was the highest reported cases in Texas for COVID-19 cases which makes it about 43,000 cases confirmed as of

now in Houston area. It's gotten to a point that almost everyone knows someone who has been infected. Governor Abbott's Irresponsible decision to open the states is extremely disappointing and now hundreds and thousands of Texans are going to pay the price. As of now, the local leaders in Houston, San Antonio, Austin etc. are pleading the Governor to give the local leaders the authority to issue another Stay-At-Home order. These local leaders are fighting hard to make things right so it is important for us as citizens to realize that we shouldn't wait until we get a statement from leaders to stay at home and protect yourselves and those among you instead of worrying about the economic wellbeing. As we saw in the previous weeks that the leadership and the status don't listen to citizens, so we take matters into our own hands and demand change. And it's about time that we do the same by staying home, follow guidelines, wear a mask and social distance. If not for ourselves, for our community. I don't know when our government became so convoluted that the health and safety of our own people became such a partisan issue. So, please wear a mask and follow the guidelines not because it is mandated but because you want to keep everyone safe. Thank you to our essential workers for keeping our society afloat. It's sad that they go underappreciated for all their hard work during these tough times.

- Today marks the end of Pride month but certainly not our pride. On June 26<sup>th</sup>, 2015 the Supreme Court legalized gay marriage in the United States. This was only 5 years ago. Although, our nation has made really great strides in supporting the LGBTQ+ community it's important to remember that there are still gay people around the world that are not safe and are still criminalized and that there is still homophobia lurking around in our nations and within our communities. So, even though it is not pride month anymore, still have pride in who you are, who you love and know that you are always accepted and welcomed here in SGA. The strides that our nation has taken would not be possible without the hard work of the activists like Marsha Johnson, a black transwoman whose shot glass was heard around the world and marked the start of change.
- On the SGA-related updates, I have a bill going up for first read today. It is a
  policy reform act which addresses a lot of the student concerns that we have been
  seeing over the last few weeks. Some of these issues include, Sexual assault,
  diversity inclusion, as well as UHPD reform. So, stay tuned for that. The
  University Provost Dr. Short will be releasing an update on July 14<sup>th</sup> about how
  the classes will be held in the Fall 2020 semester. A silver lining is that the UH
  International Student Task force has been doing tremendously with over 20
  applicants for our program which I'm really excited to pilot this Fall. I know it's a
  tough time for everyone so please don't hesitate to reach out. We are here for you
  if you need anything.
- II. Report of the Vice-President

- Hi everyone, hope you guys are staying safe and well. I understand that the reports given by me and the presidents are kind of brief, but it is because we have a lot of updates for you guys in between meetings as we are working constantly on initiatives. If you're interested in any of the initiatives, we mention in the senate meetings, please reach out!! We would love for you guys to be taking some of them and be part of projects. We reached out to a couple of senators to be a part of work groups, which we will later on reflect more on during the meeting. We are, like the president mentioned earlier, working on plies to improve our campus.
- The president and I had a meeting with A&F in which we discussed EOS. We will • be working on updating some of their reporting. As it is difficult to report discrimination so we're hoping to have a form. For those of you following Vishaka's case against Professor Houghton Brown, I'm still working with her and advocating for her suspension to be retroactively removed. I also have some Bylaw updates going up today for first read so please vote yes, they are very small minute things basically updating on how SGA already works which is not reflected in the bylaws. I am also working on cougar pack and the International Student Membership program is going very well, like the president previously reported. During our first meeting, we looked at 20 applications. They're very surprising and cool. The interviews should be set up soon. There was an SGA social which was amazing. Thank you so much for setting to our chair, Sandra Ortiz, for setting it up. It was so much fun even though I didn't win a single game. A lot of the Executive Member will be training people to register to vote. If you guys want to be a part of that please let us know. It's a great opportunity to get young people to vote right now. We can definitely swing this election and make it go the way we want to.
- Lastly, I had a meeting with Jim Taylor, University Architect. I will be writing a resolution in support of phase 2 of the student life plaza. Hopefully, it should be going up by the next meeting. We also discussed reflection places and they're not exactly what a lot of people had in mind. So, I will be speaking with MSA about working on a petition and letting the architect department know what the students want. Other than that, there are committee appointments taking place today. Please vote yes as they are great candidates. And if you guys are interested in committees please apply, I update the website daily so please check it out.
- I do want to point out that your advocacy as a senator reflect greatly upon how much you want to participate. So, if you join these committees, you're going to feel like you're making a huge difference on campus.
- III. Report of the Speaker
  - I have a lot of people contacting me that they can't come to these meetings, which is okay a couple of times, but I do want to remind you that if you miss too many

meetings you won't be able to continue the summer senate and would have to wait till fall to continue with senate. But if you do miss meetings, you can appoint a proxy and have another senator fill in and vote for you. All you have to do is ask the senator of your preference and have them vote for you and let the speaker know that you will have a proxy for the meetings. You can only have proxy for one person so make sure you choose someone good. Other than that, we have been working with the International Mentorship Program. I attended the meetings and did an interview along with David Hilton with one of the mentor candidates. She was great and we really liked her. The social was great and I had a lot of fun. We should do something like that again.

- IV. Report of the Chief Justice

Also, I reached out to all the applicants of the mentorship program last week and scheduled interviews with them so we will be conducting those interviews in the coming weeks and select correct applicants.

Also, want to have the marking out 2-3 days before the elections as the people tend to ignore it. I wanted to also have like a competition or a raffle for which you can gain 1 entry when you vote and there'd be different stages which will be covered later on. I also wanted to work on having a little event because I know the COVID is worsening so we can ensure that there is social distancing in the event. It would have all the parties invite and speak but due to the current situation I will need to figure more things out on how it will go down. And of course, having a presidential and vice-presidential debate because the last one surfaced up some great arguments and opinions. If the COVID situation is not getting better than I will focus on digital marketing more like on social medias as well as contacting professors with 100+ students about sending out a mass email about the event. I would also work with other election commissioners from the other UH systems and see what ways they're using to have an election during COVID. Regardless of whether we're social distancing or not, I would host social media contest for prizes. I would also like to publicize the platform to those that are running board positions which will make it easier for students to know what they stand for. I will host election seminars because I believe if people had opportunity to ask questions and figure out who is ready. I would also like to communicate with Becca and ask her about her Election Journals as she has a 2 year experience as an Election Commissioner.

- V. UB 57002 Policy Reforms Act (First Read)
  - This bill covers a lot of different topics. Firstly, it talks about sexual assaults and the mistrust that the universities have in general regarding the complaints. The workgroup will be assessing whether any assistance is needed or if they need more funding, what the process is whether somebody will get sanctioned. 6 students from the College of Social Work wrote a petition with over 1,489

signatures from UH community to ensure there is not anti-blackness at an institutional level. In this resolution petition, they call for transparency between the relationship that they had with UHPD as well as the eradication of racial profiling by the UHPD, it also calls for de-escalation training. There will be workgroups being made to help with the implementation of the order on campus regarding the issues. There will be workgroups created for diversity inclusion, a UHPD reform, Sexual Assault and Misconduct improvement and freedom of Expression establishment.

- VI. SGAB 57005 Public Engagement Reform Act (First Read)
  - This act was created to make things more flexible. The main part of this Bill is giving us three options to choose from to engage with the public every quarter. Every SGA senator would be required to:
    - i. Host a townhall with the people you represent
    - ii. Have a meeting with two (2) registered organization student leaderships
    - iii. Simply attend an RSO meeting and give a presentation followed by a Q&A session with the RSO
  - The format of these meetings will be determined by the executive branch, specifically by the speaker of the Senate. If you don't attend one of these meetings, you will experience an absence.

- VII. SGAB 57006 Bylaw Clarification (First Read)
  - This bill is just to take out two clauses out of the Bylaws. These two clauses should not be in there as that is not how the SGA works right now. First one is Title V, Article 2, Section 5 clause 3 which states that SGA Justices are automatically appointed to the Hearing board which is not how the hearing board works. Second one is Title III, Article 1, Section 4, Clause 7 which states that the Vice President has to put up a list of every single person that has been appointed to a committee which was not done by the previous VPs and also there is a privacy issue.
