- I. Report of the President
  - Everyone so thanks again for coming to today's meeting it's the last meeting of the Somerset and I know that's super exciting I just want to express my gratitude for all of you for staying inactive SGA, despite going through not only a global pandemic but a civil rights movement and all of the quarantining and social distancing that I know can take a really big toll on people's mental health. I'm really proud of everybody in this administration, honestly and I just wanted to express my gratitude over the last few months the 57<sup>th</sup> SGA has passed 7 SGA bills, 2 University bills and five student government resolutions despite being completely virtual. Furthermore, our SGA did not stay silent when our black peers we're under attack and our SGA did not stay silent when faced with misogyny in our own organization. I want you to know what to expect from this administration going forward expect us to always use our voice even when it's an unpopular opinion and continue to be the voice of those who are under-represented. With that being said, as a result of the various work groups that I and others in the Senate have been a part of, you can expect us to be pushing for mandatory trauma informed training for UHPD increased accountability for UHPD and in light of all

the activism in the importance of activism in bringing about changes not only on our campus but in our community at large. we'll be pushing for creation of a document that outlines how student's faculty and staff can peacefully protest at UH. I also had a meeting with UH athletics this past week and we talked about hosting a food drive during our first home football game September 26th but that's only if football season does not get cancelled which it looks like it might get cancelled but that food drive is going to benefit the College of education teams pantry and so we're going to be needing volunteers for that as well as a tabling that we're planning on having in the fall. we are planning on having two volunteers at each table that we have in the two volunteers for the table in the student center one person from the exact issue voter registration and then one senator that kind of talk about their experience in SGA. so, if you guys are interested in volunteering please reach out to the speaker and let him know that you're interested. Lastly, September is Hispanic heritage month so I'm going to be working with the PR team so hopefully we can put some nice marketing materials out there and celebrate our Latinx brothers and sisters. I just wanted to say that I'm super proud of this administration so far. moving forward I really want to put an emphasis on ADA accessibility, that's something that is really important to our administration and we were thinking of sending out a student survey to the students with disabilities on campus and seeing what are some areas that they need support so if you guys are interested in that or have any insight on that please let me know or let anybody else in the exec know and we would be happy to talk about that but yeah I'm super proud of this administration I hope you guys enjoy the meeting.

- II. Report of the Vice-President
  - Hey everyone. So some updates on some initiatives that we've been working on lately Muslim inclusive reflection spaces so we talked to Jim Taylor recently Sterling and I and he is going to be taking the two additions, the carpet and the shelf, through the design team soon so we should hear back soon and I think today was a success, we'll see in a couple weeks though. Regarding the student life Plaza resolution, if you go to the Student life Plaza, which is to the left of column performance Hall, it already looks nicer. I can't like pinpoint exactly what it is, but it already looks nicer and better. So, thanks to both of the resolutions that we passed in the past week meetings. For the work groups, I was thinking about giving you guys some updates which means that my report might be a bit longer than usual but I think you guys care about the work groups because they came from the US revolution position and all the activism that's been happening the past couple weeks so I thought it was important you guys are up to date. In the sexual assault and misconduct work group, we're talking about providing more resources to the women and gender Resource Center because they do this really

great training for faculty and staff, it not mandatory and I think students are allowed too, on just how to help students deal with sexual trauma, we also talked about having a specialist at CAPS in sexual assault and trauma to help students through it. In the freedom of expression work group, which works on protesting and activities on campus we talked about basically educating students better and like the president said we're just going to work on having a very comprehensive very easy to read document so that whoever wants to start a protest or whenever on campus they know exactly how to really know all the rules. For the diversity and inclusion work group, right now we're researching different training models to help students see diversity and be more inclusive and faculty and staff and everyone. In the UHPD work group, we're working on improving the way we report officers basically, other than that, we are going to have COVID testing in the fall I don't know if I'm allowed to go into the details but essentially, it's going to be pretty affordable it's going to be around \$7.00 and they will be taking third party insurance. I've also been working with the faculty Senate to kind of talk about how to make our curriculum more diverse because I know a lot of us especially in philosophy, we read a lot of books and philosophy by white individuals so it's good to have a more diverse spectrum, other than that, please apply to committees. I have three appointments going up Jasmine and Chiamaka are both going up for the hearing board and if their appointed, there will be 4 spots left so that I can point to and if mattie is appointed then there will be 1 spot left on the CSD Advisory Board. that's pretty much it. reach out if you have any questions or want to work on any of these initiatives with us

## III. Report of the Speaker

• So, the next meeting that we're going to have is in two weeks on the 26th it's Wednesday it'll be over zoom. I went and updated on the website all of the bills and resolutions and University bills that we passed so people look at it. they've all been signed and stamped with an approval stamp. I updated the vacancies on the Senate positions at two. I think by tomorrow I'm going to update the minutes and such, on the get involved website for organization I will put up the senate vacancy submission so people can once again apply for Senate vacancies websites center if you go to the SGA website go to legislative branch Senate directory you can see the vacancies or if you know anyone that would be interested I'll just go through really quickly 3 graduate at large, 1 College of education, 1 hobby school of public affairs, 1 hotel and restaurant management, 1 College of law, 1 CLASS, 1 College of Nursing, 1 NSM, 1 College of social work seat and 1 college of Optometry. If you know anyone especially CLASS and NSM tell them to apply I'm hoping to do interviews or one of us will be doing interviews and hoping to get those people in our very first Senate meeting. I'm also going to be sending an email to senators kind of prep them for this fall semester, especially those that

didn't do summer senate just to kind of help them out refresh them, so they don't come in here completely blind because it's been like 3 months.

- IV. Report of the Chief Justice
  - Hi everyone, I hope you all are staying safe. For my report, unfortunately I might have to postpone the Supreme Court retreat because of course we're still down one associate justice and I rather have all of us there in order for us to continue to be successful versus having one justice miss out on something. the other thing is the Supreme Court had a meeting last night and we talked about some of the some of the acts and some of the resolutions from previous administrations as well as current too. the other thing is making sure that the associate justices are doing great during this time as well too. I have a new associate justice here with me today, Stephanie. she's an associate justice on the Supreme Court. she's joining me today. I also ordered some stuff for our associate justices as well too for the female justices. so, when we take our Supreme Court pictures, they can look more unified and of course they can be a little bit different from the male Supreme Court Justice.
- V. Report of the Attorney General
  - Hey everyone, so this is pretty much my last report. I don't have a ton to report just about you know what we're doing at the Department of Justice. we don't have any our super pressing things to review. Again, the offer still out there anybody here is thinking about running for SGA in the following administration, feel free to reach out to me. this is the last day that I don't know when the website's going to be updated. if you want to talk to me, just email me or you know whatever add me on Facebook or something. Caitlin will become the attorney general after this meeting and so if you have any other you just use the same email as she should have access to it and she'll be the attorney general from August 13th until she officially takes office for the full term on August 1st and then if she doesn't get reappointed she'll serve until August 1st 2021 and that's pretty much it. Other than that, I've been I've been in SGA for almost five years now and it's been 5 out of 23 it's a 20% of my life has been student government pretty much which is crazy to think about. So, I got a lot of opportunities through SGA. Although, it didn't help me get a job or anything like that but what it did help me do is just having somewhat of an impact on the community while I was in UH in college. I actually just got the email from UH that I was apparently awarded my Masters in finance about 15 minutes ago and so five years, 3 degrees a lot of initiation that I did, a lot of friends made along the way. And the last thing I wanted to say is that all the administrations I've been a part of, this one's been the best including my associate that's what I'll say to Maya as she didn't have to deal with the pandemic, didn't have to deal with the biggest protest, erase relation issues in the whole country's history. I think that Jasmine's

leadership has been great, she definitely handled this better than I would have, better than Allison Sean. I think she handled it better than any of us would have. the whole executive's been great and it's awesome that you guys are still going to meetings all that stuff during all this. Hopefully, you'll get at least one meeting in the chamber before the administration's over.

  - Hey all, I don't really have a lot of updates. I've had three people apply for deputy election commissioner but I'm still looking for more so if you know anyone that would potentially be interested, have them apply online on get involved and I'm also going up for a committee. Thank you.

- VI. Reports of the Graduate and Professional Students Committee
  - So, we have two main things that we've been working on. Firstly, the graduate Bill of Rights, we are maintaining our Bi-weekly meetings with Dean Larson who's the dean of Graduate School and we're courting with the graduate and professional students committee which the University committee for us regarding what exactly want to do with that and how we want to go forward with it. We have the issue of whether we want this document to be something that's mainly a list of resources for things that are already policy that grad students and freshmen students can pursue in order to have their issues addressed or/and a document for what we want to see of policy University policy. So, it's seeming like we're going to have two separate documents for that or one document with two sections outlining both of those things. we'll get more information in the next meeting about that. Secondly, we had a joint committee meeting with the Graduate professional students Association regarding having representation in SGA as you can see there's not very many grad and professional students, even though there are slots empty for that. So, we're going to be working with them to make sure that we get some more GPS people in SGA so that you know our voices are accurately represented. So, that's the two things we're working on an looking forward to working with the rest of the year.

- I. University Committee Appointment (University Hearing Board) Jasmine Khademakbari
  - Hey all, the hearing board is a committee that I was a part of last year. the hearing board only hears a few cases every year, so I didn't actually hear any cases last year, so I wanted to do it again in hopes that maybe I'll hear a case this year. But I felt like I was prepared for this position mostly because last year I served as the panhellenic exec's VP of judicial affairs and my entire job essentially was to post mediation meetings and be non-partisan, non-biased and make a decision sometimes including a monetary decision like 'your sorority gets to be fined this amount of money' and oftentimes it would be my sorority or other sororities and I had to remain you know impartial. So, that's why I originally applied for it last year I felt like I could not only be non-biased, but I also had already some experience in making these kinds of decisions even when it affected my own organization. So, for those of you guys who don't know I'll give you a little bit of background on what the hearing board is. Essentially, it's made up of student's faculty I believe a

staff member and it's only three students that end up getting called to every hearing and they have a kind of a larger pool of students that they kind of choose from. so if there is an incident report filed against a student if they do violate some part of the code of conduct and there is an incident report made against them, that students has the option to either go and have their case heard by just the Dean of students or they can opt into having their case heard by the hearing board which is students faculty. So, it's their choice that's in the hearing board will kind of determine if there was a violation and then if so, they'll determine what the appropriate sanction is as a result of that. So, I've read through the code of conduct of the University obviously, so I feel like I'm pretty prepared to hopefully serve on the hearing board. So, I hope you guys do choose to appoint me that would be great.

  - Hey all. So, I basically wanted to be a part of the hearing board because it gives students the opportunity to prove whether they are innocent or guilty and I think it's really important for students to have because not always faculty and staff are on the same page as students. So, I think it's really important that they have that representation they have those fellow students on the board who may understand their situation better than say a faculty or staff member.

- IV. SGAB 57008 No Tolerance for Sexual or Violent Offenders Act (First Read)
  - Hey everyone. So, this is modeled after a bill that passed last year and it basically prevented people who had been reported or search sanctions for sexual assault or misconduct or anything then they can't run for SGA and this bill just takes it a little bit further and prevents those students from becoming part of committees, at least on SGA side, which means that SGA cannot appoint representatives who have been reported and sanctioned for sexual assault misconduct and any other violent offenses. I wrote this with Attorney General, so I'll be doing questions with him let me know if you guys have any questions.

- V. SGAR 57006 Resolution in Support of Quad Workers' Rights (First Read)
  - As the name implies, this is a resolution in support of the quad workers. So as some of us may have heard and have read in the daily cougar there in October of

last year, there was a group of workers that worked on the quad replacement project who claimed that they were not being paid the wages that they were owed while working on that project. In January, the University released a statement regarding the situation essentially saying that the contractor that they had hired to construct the quads that they were clear ground doing essentially what the statement kind of implied there is some more organizing protests as some of us may have attended those protests and the nine workers that initially came forward with these allegations as we saw in a July 15th article in the Jimmy Krueger settled with the contractor to receive pay. so essentially say intentionally the contractor admitted through that settlement but since they settled, that should imply something that was not consistent with what the initial statement in January was released. So, of course there were not only nine workers who work on that project, in fact, there are hundreds to thousands of workers who work on that project and this labor dispute is not isolated to the nine workers, in fact, there are two new groups that have formed of there's one group that's trying to organize the rest of the workers who have not been getting their wages, there's another group that is getting legal representation to try to pursue the same route that the initial night workers did. So, right now where we're at is the University of Houston has had their initial or the last installment of payment to the contractor due August 1st usually what happens with these things is that they wait 30 days after the due date to actually make the payment. So, in this situation according to Texas law the University can withhold the money that's owed to people from the contractor if like an allegation is ongoing or if there's a dispute that's ongoing and so that's where we're at right now. To recap, we're at lots of workers who have not been paid the wages that they are owed, the University has the power to withhold some of the last payment to the contractor as a consequences for not paying their workers and then we have a petition which I will actually include in the social group chat later today, a petition by the rest of the workers demanding of course for the payment but also for enforcement mechanisms here in University policy where if something like this were to occur again it would actually be follow up and that there would be consequences in the case that a contractor has shown that they did not pay their workers. So, the language of the resolution right now does not reflect all of that and I intend to edit it to reflect everything that I just said. I had a meeting with workers defense project which are the people who were helping organize all of this stuff today and I'm going to continue working with them as time goes on but in their meeting they said it would be very powerful with the students were able to send a clear message to administration that we do stand in solidarity with these workers and that they do deserve to have their wages paid. Why should we care about this? essentially if we have one worker on this campus that is unpaid or that is treated unfairly that means that every single

worker on this campus can be unpaid and treated unfairly. I hear from a lot of other grad students, professional students who are teacher's assistants, research assistants are not paid with what they deserve who have too much work put on them for no pay or for no extra pay. So, it is indicative of a wider problem institutionally at this campus, where workers do not have the recourse or the education for the recourse or the follow up from administration to actually have their concerns heard and for their rights to be enforced and so that's essentially the purpose of this resolution. anyone has any questions on this I will be glad to answer it as much as I can.

- I. Comments and announcements of the Officers
  - President: Hey everyone, there was one thing I forgot to mention in my report that there is going to be a panel regarding the new local election that's going on for commissioner and it's about the environment. so, if you guys are interested in sustainability and local politics, I really suggest that you come. the SGA going to advertise that panel. so, you guys should see that in the next coming weeks so. for the fall, some updates on the SGA office. Usually, in the past, a lot of us have hung out at the SGA office. Unfortunately, that's a thing of the past now as the capacity in the office is going to be 3 people. So, when our office coordinator is there then only two people can be sitting at the tables. The main table in the office in the common area and it's one person per office. just so you guys are aware the SGA office isn't really going to be that fun social place that maybe it was before. But hopefully that will change if we all follow our social distancing guidelines and where are masks then we can go back to those times in the next coming months or maybe this spring semester. just keep that in mind if you guys want to meet with us just shoot us a message and we can try to coordinate a time, if you do want to meet in person and if people are comfortable with that. so, everyone wears your mask and hopefully I'll get to see you on campus soon.
  - Vice President: Great meeting everyone, it was really nice talking to you guys and I am glad I summer senate is over because now I get a little bit of a break. Hope you all stay safe, let me know if you need anything and please apply to committees that's how you make change on campus.
  - Speaker: Congratulations! We made it through the summer now it it was a long road. Like I said, I would've had more meetings if they let me, but this is what we had so, good job guys. we're not slowing down; in two weeks we're going to start our first meeting. I'm going to crack down attendance if you don't show up to your meetings, I'm kicking you out of my organization. besides that, there are vacancies open so we're probably going to ask justice to post something on social media to try and get people to apply but please apply because I want to build this

as soon as possible. So, I want as many candidates as I can choose from as soon as possible and hopefully put them up for the first website.

- Chief Justice: so again, the Supreme Court retreat has been postponed as I am waiting for the next associate justice to be appointed and then we're going to go from there. I'm still going to be contacting people from different areas within SGA, that way they can make an appearance within the actual retreat and introduce themselves to the Supreme Court justices.
- Attorney General: Everyone, so got a couple more things here. So, I was very disappointed at the lack of gift cards that were sent to my apartment. I'm going to give you guys one more chance to give me some going away present. I've already initiated the transfer So, anyone else has anything else they want to send me, I am I'm perfectly willing to accept it and other than that I promise not to be one of those alumni that's like weirdly still coming to SGA meetings even though I'm way too old for that at this point. so, this will be my last meeting and I will be leaving the GroupMe tonight so that's pretty much its guys. I'll see you guys around.
- Chief Election Commissioner: Yeah Cameron go get yourself something nice at the dollar store with that money I got you bro. Other than that, I had a great summer senate. Take care. Bye.
- Chief of Staff: Hello, Sterling said that it was a nice meeting and he looks forward to the semester. in terms of the deputy, it was a good meeting. I love all of you. it was a fun meeting and I look forward to rest of the semester.
- External affairs: Good meeting everyone!
- Senator Morgan: I just want to give a quick shout out to Cameron, he probably doesn't remember but about a year and a half ago, when I was a freshman in my second semester really wanting to get involved and find some organization to get a part of I tried to join SGA submitted my application I didn't really know what I was getting into. It was right before the election, but Cameron was the president and he actually interviewed me, gave me a shot and allowed me to be appointed. I was super terrified to go up in front of the Senate, but it worked out and I was super fortunate to be a part of this organization. so being in three administrations with Cameron, I wanted to say thank you for everything you've done for the students, for this organization and thank you for giving me my start in this organization. I really appreciate it!
- President: I wanted to share my Cameron story.
