  - Interpreter Iglesias: I am Chile Iglesias and I am the Houston campaign manager for workers defense project here in Houston and I have well we have Omar Martinez who is a, Spanish Speaker, with us today I will be interpreting for him.
  - Omar Martinez: Good evening, my name is Omar Martinez. In May of 2019, I started work building the dormitories at the University of Houston. I worked at that site for 10 months I work as a drywall hanger an framer I was making \$14.00/hour. However, the work I was doing had to be paid at \$17.44/hour \$21.37/hour. About 3 months later, I started working at that job site. During that time, we made friends with other workers in other trades such as plumbers, electricians, an HVAC installer and because of that friendship, we found what prevailing wages where that we were not being paid up properly. Every Monday, we had a meeting with the four men of the company who reminded us that we were not indispensable. They stressed was that we were very lucky to be employed, in some way, humiliating and intimidating us. I did not take any action on the matter because I did not know how to do it. Eventually, I realized that there was a group of workers who were organizing to the man payment for prevailing wages owed then I joined the fight with workers defense project. This group of

workers made claims directly with the University that we do not have legal representation. On June 15, my colleagues and I submitted an incident report on the University of Houston website. we did this because that was the solution that the facilities and construction Department recommended that we do. a month went by without being called or email. Then mid-July, we called the facilities and construction office is asking to speak to executive director of construction projects Nicholas Mary. Nobody spoke Spanish in those offices. the person in his office gave us a phone number for another Spanish speaking person who works in the office to leave him voice message. End of August and as of yet we have not received a call from Nicholas Mary's office. the solution recommended by the University has not worked now more than two months later. I feel frustrated and disappointed by the university's inaction to see how they are workers like me who have not received or the salary that corresponds to us and the owner of this project is the University of Houston. Thank you very much for listening to me. I hope that this testimony that I am doing will not only help me and my coworkers but also future construction projects at the University of Houston. After more than a year of fighting, you are the first officials of the University who have listened to my story. I am only one of the many workers who were involved in that project and I am confident that you will make the difference that we need have a good evening.

• Nick (Staff Attorney): Hey, my name is Nick. I'm a staff Attorney at workers defense project in Houston. Yes so everybody thank you for letting us speak today. it's been quite a year that we've been working on this with a group of workers at the University of Houston who are on the quad project. so basically all of this boils down to a fairly straightforward legal issue that I'm happy to answer questions about but I'll just give you a brief overview of what the basis is of the wage theft claims that these workers have been bringing forth. so as I mentioned earlier on the staff attorney forward hands project, I represented the group of nine workers who originally came forward back in October or November of last year. we were able to successfully win a settlement for them for their claims but after they brought their claims and managed to get some justice, many more concert coming forward sharing basically their experience with almost the exact same problem that super nine had experienced. And the basic issue here is a minimum wage violation except it's a little different because it's a public construction site. so everybody's familiar with the minimum wage. everybody knows you're not allowed to be paid less than that. generally speaking for construction, when it's a public entity that paying for the construction project happened like a public University paying for going to be built, there are higher minimum wages that are required for the construction workers on that site based on the type of work that the construction workers are doing on that site. so if you're doing the work of an

electrician, you have to be paid at the rate for an electrician in these rates as set by the Department of Labor at the federal level and usually those rates are adopted by the government officials at the local level. So, Omar shared he was doing something called drywall hangers work which is important especially in a dorm because you have lots of rooms in a dorm obviously and you need to hang a lot of drywall to basically put up the walls that make up the walls of the dorm of those dorm rooms himself. that's what it looks like we're the hallways or the building we need drywall. So what this comes down to is like how much does a drywall hanger get paid according to the prevailing wage rate and that's the wage rate that's set for drywall hanger in public construction site. so the prevailing wage rate for drywall hanger in Harris County is \$21.37, that's how much you're supposed to get paid in order to do this work is that majority of the workers we encountered who were doing this kind of work on the site were getting paid anywhere from 25 to 30% less than that. so a lot of times it would be you know \$15.00/hour, \$17.00/hour. \$16.00/hour, or something like that and not \$21/hour. So, if this were just an innocent mistake that might be one thing what we are seeing is this is happening systematically across the board to a lot of the workers on that site out every single worker but a very large proportion of them it's more the only workers we've encountered who have this problem so far have been primarily Spanish speaking Latinx workers and uh you know that seems very concerning to us it's something that we have brought up when we were bringing attention to this issue in the past and I think it's something that should raise a lot of red flags or anybody is concerned about this um so I I think uh the last thing I want to mention here the way that you enforce this law is something that I think has been a point of contention with the universe so the way this law works at the state law and the state law says OK these are the prevailing wage rates if you're a drywall hanger you get paid this amount you electrician you get paid this amount the question then is who do you report this to if you're not getting paid that amount and who's going to do something about so under the law under the state law I am happy to share a link with you guys afterwards I can send it to you after I'm off this call under the state law the way this works is different workers thinks they're not getting paid correctly they're supposed to report that wage software that complain to the public entity that's paying for the construction to happen in the first place so here Omar a correctly decided to report his problem to the University of Houston because it's the University of Houston project they're paying for this construction project so you have to go to them to get their help pushing block University of Houston at that point is supposed to look into the complaint here the complaint the law is not super specific about how you do this but a lot of common sense would tell you what the next step should be should probably talk worker should talk to other workers and see if they have similar

problems on the site you should compare that with what you're hearing from the employer and then weigh the evidence and then figure out if you have follow-up questions and then Richard decision um it's been very difficult to get a straight answer about exactly what went into the process that the University of Houston is used to investigate the complaints themselves about forward in the past and the only complaints that were aware of the University of Houston investigating so far has been complaints brought forward when I was representing a group of workers as their lawyers we have limited fuel capacity and many workers have come forward so workers like Omar have come forward and these issues and nobody followed up with the University administration now the Alaska of this is to say University of Houston after it's like looked into the matter it is supposed to render it's called its initial determination and the initial determination is final as indicated in the title it's an initial determination if the worker disagrees with what the University says the person says we don't think you have a good claim the words that can appeal it to arbitration with the contractor so but the weird set up it's a little counter intuitive but the University essentially sits as the judge of the complaint that will work or brings forward on a prevailing wage theft complaint and then once universities made its decision the worker can either accept that decision or appeal it to arbitration and check the worker in the contractors arbitration so that's kind of the situation all of this you know I'm giving you along it longer than necessary probably breakdown of how the law works but at the end of the day all of this comes down to a very simple fact University of Houston is a big powerful institution Houston they paid for a lot of construction to happen on its campuses and if they say they want the construction done a certain way in a way to make sure that workers are paid properly and paid correctly and on time and the proper amount if they wanted to have monitored checking on those things there contractors would do that they would certainly live up to whatever the University of Houston requires that their contract but only at the University of Houston asks for it and hold his contractors accountable. I think that covers most of what I wanted to share I don't know if anybody has any questions about it I'm also happy to answer questions outside of meeting if you all want to talk later about prevailing wage law the state statute or how it applies here I'm happy to help answer those questions.

- IV. Two-minute speeches by the members of the Senate
  - Senator Gil: Hi guys. Welcome back to our first meeting of the fall. summer senate was pretty cool, President, Vice President, Speaker and all the officers, they did a great job this summer. when it comes to this issue, I was kind of sensing a rush but I think it's important that we take our time with an issue like this 'cause if there is anything that we can change is if there is anything that we have the power to change and it needs to be done and I know the executives in

this organization mysterious the right way it makes sure that justice gets done for those people but I mean this is just a case of straight negligence on the part of our University and I don't think how I don't think that you know anybody should feel comfortable with just letting this slide under the rug um so if we need to go in depth with this and if you know we can make real change then I encourage everybody to let our executives take control and let us help those people 'cause this is really important issue and it's honestly going to be one of the most important issues we probably face as a student government Association because like I said before these people's livelihoods that were messing with or he was a livelihoods that we are could affect you know that could be Mr. Martinez his money he could use to put food on the table so um thank you Senator Garcia for bringing them to the forefront and I hope we have a good meeting. thank you, guys, again.

- Senator Davis: Thank you Senator Gil, you were right. we are messing with the • livelihoods and we have to do something to make a change. with that knowing that the power that we do have and I'm grateful to see that resolution as well that Senator Garcia drafted up. this is our first Senate meeting of this semester, it is online. I'm just going to recap this week that while my students, we got this even though it's virtual. even though this may not be what we expected. this change is going to take us to where we need to go. this school year will be prosperous with support, purpose, passion patience & productivity. remember this is only temporary. let's just stay focus and be great. let's become the great leaders that we are and with that, I would transition into my brief report of work groups that I've been working on this summer. I had the pleasure being in the race relations and social justice committee, Co-chaired by doctor Elwyn Lee and Dean Robert McPherson, in that work group by compiled resources based on criminal justice, Mass incarceration, policing, history of racial oppression, racial inequality's community development and other topics. in the second work group that I had the pleasure of being again is that diversity and inclusion work group. within that group I took on the tasks on recently being involved in cultural competence training requirements, campus climate survey and the respect UH campaign and telling campus culture committing to. that is all I have so far. we're getting to work first senate meeting, let's get to it.
- Senator Sasser: Hello there everybody, Just want to start off by saying that my father is a contractor and has been for more than 20+ years. this whole situation that was just said, I forward it to him and he says what happened in this situation usually happens because they don't have the papers or the money, or they just want to take advantage of these people, which is very common when it comes to contractors especially for the people that don't speak English clearly. on the side note of that too, I've been working with hero 19 committee of our scholarship to

help out medical workers essential workers and so far it's almost as halfway and it's almost done and I hope everybody is doing good.

• Senator Hamad: Hello everyone, I hope everyone had a great start to the semester. I just wanted to thank everyone for great summer senate. I'm glad to be back in Houston so no more 4:00 AM meetings for me. for this serious topic that was brought up right now a lot of people are going through this and probably even worse so thank you Senator Garcia for bringing this up and we need to work on it because personally a lot of my friends who have family members that are going through the same issues as well. So, let's start this semester well and stay positive and just looking forward to another great meeting.

#### Clause 5: Executive, Speaker, Court, and Justice Department Reports

- I. Report of the President
  - Everyone good evening um welcome to the first official meeting of the fall • semester of the 57 student government Association I'll let senator Garcia speak more on this but the quad worker situation is a prime example of the impact that student government can have an opening the doors for communication with administration so earlier today actually John Julian and I met with general counsel of the University to talk more about solutions and hopefully to create a work group to open dialogue between the University contractors Workers. the new Ouads are beautiful and to know that the workers that contribute to the beauty of our University have not been heard or treated with respect and dignity is completely unacceptable by these contractors that were hired by the University with September being Latinx heritage month I think it's important to address that Latinx people in the United States have been exploited for their labor for generations and the University has a responsibility as a diverse institution and as a Hispanic serving institution to ensure that workers are not being exploited and that they are treated with respect. I remember when I campaigned for student body president I took a break with Daniel, our deputy chief of staff, and we spent several hours at the quad workers protest. so thank you so much John for writing the bill and for bringing in Nick Chile and Omar an I'm excited that we have the opportunity to stand up with with these workers and prevent anymore complaints like this in the future. so but that out of the way I want to welcome everyone who's newly joining our SGA family for the first time this fall semester and I want to give a huge thank you to everyone who participated in the summer Senate and I want to take some time to reflect on the accomplishments of the 57th administration so far and highlight some great individuals and work that had been done so Sabreen and Jade, the chair and vice chair for the academic affairs committee collaborated with administrators from the office the provost to advocate for medical emergency W that we actually campaign for and brought

student awareness that policy, two months into this virtual student government administration I wrote the international student support act that created University of Houston's first international student mentorship program. through an executive order I created the international student membership program task force and I want to personally think senators David, Paul Hilton, Sidney Blakely, Ester Arias and Annie Kim for helping us create that program and thank you to our speaker Julian for becoming the chairperson of this task force for the fall. Our administration has been no stranger to challenges when the ICE regulations were released that threatened the safety and stability of international students in the United States. I worked with our external affairs director Jessica Hewlett and she contacted all of the Texas student governments and we were able to together send a letter to the trump administration advocating for an end to these policies. former senator and chair of the internal affairs committee and now election commissioner Chiamaka Chukwu has not stopped her advocacy for representing underrepresented students or passage of the resolution in support of revenue of renovating garage 5 increase student safety on campus and is going to make that area more ADA-accessible to support students with disabilities. Vice president Rashid who is in many ways my foil and compliment shares two qualities with myself and many of us in this administration and that is her passion for change an her willingness to be outspoken even when it may be difficult when plans for reflection spaces in the new UH medical and law school were not inclusive to students of all faiths she spoke up in partnership with the Muslim student Association and she created a petition and are open past the resolution from Muslim inclusive reflection spaces and she made that change my chief of staff Sterling white who just a few years ago was my competition during our election for Senate has not only become my lifelong best friend but has been a great source of support for the entire cabinet Sterling and his deputy Daniel had been working hard for developing our emerging leaders Interxion program for the incoming freshmen and 1st year transfer students a few who are actually present today not only has the 57th SGA works through a pandemic but we've worked alongside a civil rights movement. the murder of 46 year old father of 3, George Floyd, by police sparked a cultural change across our nation and shed a light on the systemic and institutional racism and antiblackness that has plagued our society for longer than the novel coronavirus has and for the first time the UHSGA did not stay silent and we took a stand against police brutality systemic racism and openly voiced our support for the black lives matter movement and protests I worked alongside senator Kenneth Davis the 3rd to open communication between the sea and the historically black organizations on campus and together we passed the say their names resolution a resolution with over 20 sponsors from organizations across the campus where we called on the

UH community to stand in solidarity with the black community there's so much I'm so sorry all the nationwide civil rights movement inspired huge students to call on our own University to make change and we passed the policies Reform Act that united SGA members student organizers of the NPHDUH revolution petitions faculty and staff to work on policy changes related to diversity inclusion freedom of expression sexual assault and misconduct and UHPD reform and in the coming weeks you guys can expect legislation highlighting policy changes that we have made as a result of these work groups and I wanted to thank Sterling, Hiba, Chiamaka, John, and senators Wolfe, Ubina, Garcia and Davis for taking the time to be apart of these work groups. I know that none of us expected the 57th SGA to make history by being UH's first ever virtual student government Association because of a pandemic but all of this hard work would not have been possible without speaker Julian Cheng who was responsible for making our SGA meetings go smoothly despite not being in person and our PR director justice and outreach director John have been making Flyers and are going to be bringing us virtual events to increase SGA visibility during an almost all online semester in light of the pandemic and all of the essential workers who are instrumental in making our society run I wanted to highlight senator Jonathan Sasser who created a huge system wide hero 19 scholarship with Sterling for student essential workers which is awesome and I know that a lot of people might believe that our administration was short change this year but honestly I disagree it has and will continue to be a privilege and honor to lead this organization I am proud to be part of the historic student government Association that stood up for injustice and has not stopped working hard since the first day we got in office on Sept on April 1st despite not getting the perks of the other years the SGA has always been a selfless organization at its core the SGA has never been about the fancy offices although they're nice the Senate chamber or any perceived recognition that some people may think the student government has the student government Association will and will always be about creating a better future and I'm proud to leave it an organization full of dreamers leaders and advocates and passionate people so thank you all because every single one of you who puts effort into this organization will be responsible for a better University of Houston years down the line so thank you so much for a phenomenal summer sent it and I look forward to an even better fall semester

- II. Report of the Vice-President
  - thank you all so much for attending this meeting in the middle of a pandemic and a hurricane. this shows how dedicated you guys are and that makes my heart very happy. if you're in any way affected by anything that's going on, please reach out I'm always here to talk or provide support whenever you guys need. I'm glad Jasmine kind of slowed us down and talked about what we've accomplished so far

because and anyone can tell you, all of us are always just working and trying to work on the next thing and looking forward and saying "hey this is a problem we need fix this" and we never slow down and take the time to realize how much we've done already online. I'm really thankful that I'm part of this administration it's always the highlight of my day. I'm so glad this administration take cares about tough and important issues like on workers' rights and I hope we can help those guys to help those workers get justice. I'm sure we've all heard about what happened to Jacob Blake. last I heard he was in the hospital paralyzed from the waist down when he tried to break up a fight between two other people and it sucks and it's terrible and this kind of stuff happens all the time. And that is why we need to do everything in our power to fight and call out racism no matter how small or common of an act of racism might seem. Microaggressions, little comments like calling those things out and using your voice will help people learn that racism is completely unacceptable in this society. that brings me to my no tolerance for sexual or violent offenders act. sexual assault is also not acceptable. my bill is going up for a final vote today. after it passed IA, we got a lot of sponsors for this bill and I really want to thank everyone who sponsored it and if you still like to please text me in the chat box. the end of the work groups is upon us. as you all know these work groups were created in the wake of the UH revolution petition as a reaction to George Floyd's death. Their goal was

- i. making campus more equitable
- ii. making campus a safer place for black students

Jasmine and I are setting up a meeting with all the SGA wraps on these work groups to assess their efficacy and if you'd like to know more about their work please reach out to us. we've done a lot of good work, accomplished a lot so far so please reach out if you want to learn more about it or be a part of it. the most notable recommendation we've seen this past week is for evaluations to be made available to every citizen after every interaction with the police which means you can evaluate the officer that you interact with. and we met a little bit of resistance, so we'll see how it goes. Lastly, I have 4 very lovely people going up for confirmation on committees tonight. if they're all appointed there will be 1 spot left on the cougar card advisory committee and 0 spots left on the LGBTQ advisory committee column performance Hall advisory committee and the sustainability task force and that is all I have thank you guys.

- III. Report of the Speaker

- VIII. SGAB 57009 Election Code Clarification Act (First Read)
  - Hello, so this is a bill that senator miles and I are co-authoring. There are multiple • laws. Yeah it during the election but the ones candidates are primarily concerned with are the election code and student code of conduct and along with that you also have Supreme Court rulings which have to do with interpreting the election code and ideally you want all of these to be as consistent as possible you don't want them to conflict So what this does is it just to reword some of the things to ensure that the election code is clarified so that appointees don't have to look here and there to find certain provisions and look at whether it's anything is conflicting so that's all it does all it is is a clarification bill it doesn't add along take it away all of these things that we're adding in or all the existing laws in the form of this just clarifies that so with that we can go to the first provision. the first provision all that will be doing is rewording a section of the election code to make sure that provision barring candidates from having violations running violence or sexual misconduct from being used to restrict free speech or any other rights guaranteed by the constitution of out of the state or the United States. that's essentially the first provision. for the second part there were two big cases and this was because some parts of the election code that were a little unclear and so just mentioned the first one had to do with speech and what the SGA can regulate from private citizens for running the second part has to do with student organizations and so we had a case that involved student organizations being used over the course of campaigning and there were two questions that the court had to address the first was what is a student organization that was a bit vague because the election code never really defined it. there was a big issue because the attorney general defined it one way and the party to find it another way, so in the ruling the court basically just said we need to have a definition so it's clear so that candidates know what you're talking about the second question was how much SGA can really regulate the actions of a third party store organization and we said that SGA as an individual organization itself implicitly or explicitly control the actions of a third party organization. So what we did is we made minor changes just to ensure that

the law itself in spirit is the same while ensuring that the wording reflects the ruling so instead of student organization now in red you'll see it says registered to organization or University sponsored organizing that basically just puts a definition to it because register stigmatization University those are actual definitions that exist candidates defined so that it's very clear to them what they can and cannot use home second the previous part of the election code that is changed with A&B used to say that a student organization social medias cannot post this or that and given that we said that she can't regulate the actions of a third party organization it does the same thing the end result is going to be the same not the candidates instrument candidates are going to be mindful of using certain organizations for their support this just takes the object of control from the organization who the candidate which is within the realm of SGA.

- IX. SGAR 57008 Coog Strong Mask On Resolution (First Read)
  - Um hello so I'll try to make this pretty quick 'cause I think this is pretty • straightforward kook strong mask on is a campaign that the University has started to fight against COVID-19 so just a few fast facts here COVID-19 pandemic has caused for 223 million deaths or cases sorry globally an 800 about around 800,000 global deaths and the United States is now leading the world with around 5 million covid cases and over 100,000 deaths at this point and the University of Houston unfortunately resides in Houston in Harris County which I believe are we are ranked like #5 worst in the United States currently with a total of 100,171 total confirmed cases with our positive activity rate being 11.3% so that's bad. Whats even worse is that following the reopening of universities for the fall 2020 semester universities across the nation have seen a huge surge in COVID-19 cases with over 500 cases at the University of Alabama and USC had 43 new cases Iowa State at 130 new cases and that's within a week of opening their universities and many of these universities have now been forced to go completely online as a result. So in hopes that we don't have to go to a completely online semester 'cause I really want to see that Senate chamber and I know you guys do too. the University has started the Coog strong mask on campaign which essentially requires facemask to be worn at all times inside of buildings and outside when physical distancing isn't possible. The University wants to keep 6 ft distance practice good hygiene and washing your hands using hand sanitizer. this resolution just says that the FDA as a whole we agree with these new regulations by the University and some other quick facts in case you guys don't know we're at the universities advocating for students do a self-assessment make sure you don't have a fever or any covid symptoms before coming to campus and we are going

to have on campus testing center at the student Health Center that is going to take third party insurance and the cost to build your insurance is \$70.00 an uninsured students cost to \$70.00 which is pretty cheap. I work at an emergency center and they charge like \$175 for the covid test sometimes \$195 so this is actually a pretty good price for the Covid test and it's being sent to the lab that UT health which is why we can build third party insurance for that. so that's just a quick little overview of the resolution.

X. UB – 57003 – Contractor and Sub-contractor Employee Protections Act (Second Read)

I'm sure that they appreciated being heard by people especially by student government senators that was great. so thank you for that. so the reason that this change from a resolution to a bill was because of a meeting that was held today between Jasmine Julian and myself. Keith, thank you for setting that up, that was really helpful and a general counsel for UH and so this has turned from simply us expressing our support and what we think the University should do to remedy the situation. it has turned into a workgroup idea to work on internal policy for remedying any labor violations or labor disputes that occur on campus and so essentially the resolution is the same except for the fact that we have that work group statement in there and then there's also the questions that we want to ask administration in writing general counsel already answered all of those today but that was verbally that was not written and I know from working in government, everything has to be written to make sure that it happens and so that's kind of the logic there but all those questions we know the answers to already and so that shouldn't be a problem for administration but if you have any further questions let me know I'll pass along the contact information for that lawyer for people who want to ask more questions from him specifically but yeah if you guys have questions for me go ahead and let me know
