<b>Job Description</b>	<p>This position is responsible for providing non-clinical, peer based coaching and advocacy activities that engage, educate and support individuals in successfully making life changes necessary to recover from substance use disorders. Assistance may include areas such as job readiness, life skills, housing, ID, health needs, education, and recreation as well as any other identified needs that can contribute to a person's long term recovery.</p> <p>Responsibilities</p> <ul style="list-style-type: none"> <li>· Provide assistance with issues that may impede day-to-day functioning and progress in working towards sobriety and recovery.</li> <li>· Accompanies individuals through new environments, services and systems when appropriate and requested.</li> <li>· Builds on the individual's strengths, needs, interests and capabilities to improve recovery capital.</li> <li>· Utilizes Motivational Interviewing as needed.</li> <li>· Facilitate recovery based groups, trainings -and workshops as requested.</li> <li>· Directly links individuals to recovery community environments.</li> <li>· Develops and maintains relationships with community partners in various community-based agencies.</li> <li>· Complies with all Council program policies and procedures and HIPAA requirements.</li> <li>· Manages and prioritizes multiple tasks to ensure program compliance.</li> <li>· Participates in team meetings and other agency activities as requested.</li> <li>· Documentation of weekly activities.</li> <li>· Enter data into required systems in a timely manner.</li> <li>· Local travel required, must have reliable transportation and insurance.</li> <li>· Performs other duties as assigned</li> </ul>

	<p>RSPS Certification within 4 months of hire.</p> <ul style="list-style-type: none"> <li>· High School Diploma/GED required; Associates Degree in a behavioral health field preferred, but not required.</li> <li>· Working knowledge of client/community resources and able to develop relationships with outside agencies.</li> <li>· Must have lived experience in recovery for substance use disorders.</li> <li>· Experience in the use of Motivational Interviewing and knowledgeable in the Stages of Change.</li> <li>· Ability to work with diverse populations and cultural backgrounds, including different cultures of recovery.</li> <li>· Ability to work comfortably in diverse community settings.</li> <li>· Ability to work independently or collaboratively on a multidisciplinary team.</li> <li>· Excellent organizational, time management and communication skills.</li> <li>· Good written and verbal communication skills</li> <li>· Computer skills: Microsoft Office.</li> <li>· Valid Texas driver's license, proof of insurance and a safe driving record.</li> </ul>
