The CAC started in 1997 and serves over 4000 children and families annually and is comprised of a team of 22 professionals and clinicians. We provide an array of services (all free of charge) including forensic interviews, victim and family advocacy, medical referrals, therapy/mental health services, case coordination and criminal court advocacy. All services are offered in English and Spanish. We operate under a Multi-Disciplinary Team model where we collaborate with 40 partner agencies. Many of our partners are co-housed with us onsite to facilitate our child-center, community-based approach.
