A Heidi Kennedy, Office of Academic Program Management

Faculty teaching excellence award ceremony will be held on April 26. Heidi announced that Larry Williams, Martha Dunkelberger, and Donna Pattison are three of the recipients who will receive faculty teaching excellence awards. Congratulations on a job well done!

This is about the time when students will be visiting the Office of Academic Program Management (APM) for medical/administrative withdrawals. APM is ready for the student traffic. Also, Heidi will send out an email on helpful resources for dealing with student issues (i.e., drops, grievances, etc.).

B Djuana Young, Office of Admissions

Freshman application deadline has closed. UH had a 15% increase in freshman applications. The average SAT score is 1135 (higher than last year). First orientation will occur next month: 2200 students have registered so far. Orientation registration is up by 1000 registrants this year. Transfer application numbers are up by 6%.

This Friday, the Office of Admissions and the Honors College are hosting an orientation focused on scholarship recipients and honor students.

New recruiting strategies and the change in application/credential deadlines improved admission application numbers.

Djuana answered various questions from UC members.

C Stephen Soutullo, Enrollment Services

Steve Soutullo reiterated that Admissions is striving to increase average SAT scores. Within the department of Registration and Academic Records, the number of enrolled students is up by 9%.

VII Old Business

A New Core Curriculum: Libby Barlow and Agnes DeFranco

Libby Barlow and Agnes DeFranco discussed with the UC the new core curriculum and the tasks needed from faculty to help implement the new core in fall 2014.

The composition of the new core curriculum is basically is the same: there name changes to the functional component areas. A new form was created to help faculty evaluate and submit their new core courses. Libby pointed out that filling out this new core form will also help the colleges when it's time for UH's accreditation (SACS) and when it's time to reassess the core. SACS is expecting to see deep assessments of general learning outcomes. Core courses will need to assess student competency through the core objectives (i.e., critical thinking, etc.). Direct evidence of student learning will need to be included in the core evaluation (i.e., Embed student work in the form: utilize excerpts of a student's paper, include certain test questions, etc. that will demonstrate student competency in core objectives.). Libby and her office will sample only the population of students taking the core classes. UC members continued to ask questions and voice their concerns.

David Mazella offered to put web links to new core information on the CTE (Center for Teaching Excellence) blog. He added that faculty should have some guidance from the assessment staff. Simon Bott suggested that CTE along with the assessment staff could provide workshops for to fill out new core forms. Mazella agreed that is a possibility.

It was emphasized that core curriculum discussions need to begin with faculty soon, if not now.

VIII New Business

A Simon Bott announced that Kevin Simon was mentioned in a Sugarland publication as a featured wine expert.

B Updates to the Academic Honesty Policy

An ad hoc committee has been reviewing the current Academic Honesty policy for about two years. The Office of Academic Program Management submitted a request for the UC to review the policy during the summer (hopefully to be included in the 2012-2013 Undergraduate Catalog if approved). Simon Bott asked the UC to review the policy and gave them three options on how to handle this item. These options are: 1) If amendments seem straightforward and minor, the UC can agree unanimously to approve the policy via email, 2) If the amendments warrant a major discussion, the UC can meet on June 6 (regularly scheduled UC meeting), or 3) Table the policy and revisit for fall 2012 semester. Dr. Bott asked that the UC email their input on this matter.
